RE: Article 6 Information Request- AY 2017-18 faculty members holding emeritus status

Pursuant to Article 6 of the collective bargaining agreement between Portland State University and PSU-AAUP and the agreements reached to resolve UP-045-08, we request the following information that is necessary to bargain and enforce the Collective Bargaining Agreement.

- 1. The names, PSUID number, and a copy of the employment contracts of all PSU-AAUP bargaining unit members who hold emeritus rank who will be employed post-retirement at any time during the 2017-18 academic year.
- 2. The names, PSUID numbers for all past PSU-AAUP bargaining unit members awarded emeritus rank who will be employed post-retirement by PSU for the 2017-18 academic year that are not in the PSU-AAUP bargaining unit. Please provide their Labor Distribution Form for the academic year.
- 3. Names, PSUID number of all PSU-AAUP Bargaining Unit members holding an emeritus parking permit as of June 1, 2017.
- 4. Names, PSUID number of all past PSU-AAUP Bargaining Unit members awarded emeritus status who were issued an emeritus parking permit as of June 1, 2017.
- 5. Names, PSUID number of all PSU-AAUP Bargaining Unit members holding an emeritus parking permit as of October 1, 2017.
- 6. Names, PSUID number of all past PSU-AAUP Bargaining Unit members awarded emeritus status who were issued an emeritus parking permit as of October 1, 2017.
- 7. The names, PSUID numbers and email addresses of all emeritus parking permit holders suspected of abusing their emeritus parking privileges.
- 8. Any evidence collected by PSU Parking that supports their hypothesis that the emeritus parking privileges are being abused. If there are verbal accounts or suspicions of abuse, please provide written statements of those accounts that

attribute the date, time, place, and name of person, along with a statement of how they associated with the University (if employee, provide their name, email address and their supervisor's name. If there is no evidence of abuse available, please respond by stating there is no evidence of abuse.
